partment before being named chief in 2015. She is a graduate of Top Gun and a 2015 graduate of The New Jersey State Chiefs of Police West Point Command and Leadership Academy. Chief Higbee is also a graduate of Seton Hall University with a master's degree in human resources education and a master's certificate in business leadership and management.



Reverend Mike Walker

Reverend Mike Walker leads Highland Community Church in Galloway. He and his family serve with Village Missions. Pastor Mike and his wife Katie graduated from Davis College in upstate New York in 2006 and returned to his hometown of

Columbia, Md., where he worked in various churches in the area. He worked at Hillside Children's Center in upstate New York, a residential treatment center for traumatized and at risk youth. Highland Community Church has been active in addressing the opioid crisis by helping provide transportation for people struggling with addiction.



Laurie Smith

Laurie Smith is the Community Initiatives Coordinator for Atlantic Prevention Resources. She is in her 21st year with the agency and is the coordinator of Join Together Atlantic County and the Atlantic County Opiate Task Force. Laurie is also an advocacy leader for the National

to both emergency medical services and Galloway Police. Chief Uhl is in his 10th year as chief of emergency medical services for Galloway Township, and he serves as a captain in the Galloway Township Fire Department. Chief Uhl is a resident of the Smithville section of Galloway Township.



Scott Gras

Scott Gras is a person in long-term recovery - he's been sober since March 18, 2013. He is a certified Peer Recovery Specialist. Scott has been working in the recovery field for about five years. He started his career for Lighthouse of Mays Landing, and is currently employed by

the Atlantic County Sheriff's Office as the coordinator of the Hope One Mobile Unit - a program started by Sheriff Eric Scheffler. It's responsible for putting more than 200 clients into treatment since last year.
