Michael Sweeney, Hunterdon County Executive Assistant Prosecutor

Michael Sweeney is the executive assistant prosecutor in Hunterdon County, providing supervision over the team of assistant prosecutors. He is assigned to and embedded with the Hunterdon County Gangs, Guns, and Narcotics Task Force, providing legal guidance and supervision to a team of narcotics detectives tasked with interdicting the illegal trafficking, distribution and use of controlled dangerous substances. EAP Sweeney is a career prosecutor who previously served in the Orange County (NY) District Attorney's Office, the Middlesex County Prosecutor's Office and the Richmond County (NY) District Attorney's Office.
