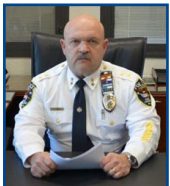
Ocean County Knock Out Opioid Abuse Town Hall Panel



Joseph D. Coronato - Ocean County Prosecutor

Prosecutor Coronato is a nationally recognized leader for his work and commitment in addressing the opioid abuse epidemic. After being nominated by Governor Chris Christie to be the Ocean County Prosecutor and after receiving approval by the New Jersey Senate,

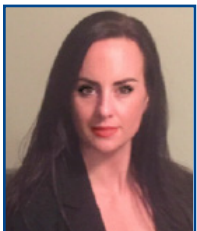
he was sworn into office on March 22, 2013. He graduated Upsala College and North Carolina Central University Law School with a Juris Doctor Degree in May 1975. In 1976, Prosecutor Coronato was appointed a Deputy Attorney General by the Attorney General of NJ and was assigned to the Division of Criminal Justice. He was admitted to the NJ Bar; U.S. District Court in 1975; Washington, D.C. Bar in 1979; admitted to U. S. Court of Appeals Federal Circuit in 1985 and admitted to practice in U. S. Supreme Court in 1992.



Chief James Riccio - Brick Police Department

Chief Riccio is a long-time resident of Brick Township and has been a member of the Brick Police Department since August 1986 and the department's chief since December 2015.

In 1989, Chief Riccio was assigned to the Ocean County Narcotics Strike Force and before being transferred to the detective bureau. Chief Riccio later was assigned to the Drug Enforcement Unit in 1996 and served as the unit commander until October 2000.



Kelli Chiarello, MSW, LCSW

Kelli Chiarello is a Licensed Clinical Social Worker, Certified New Jersey School Social Worker, NASW Certified Clinical Supervisor and Lifelines Suicide Prevention Trainer. Kelli graduated Fordham University with a dual master's degree in Clinical Social Work and Administration. She has spent the past 18

years providing direct care, education and consult in Ocean County. Kelli has devoted most of her career to caring for patients at Ocean Mental Health Services; at RWJ Barnabas as a New Jersey State Psychiatric Screener and as an Ocean

County College Psychology Professor. Kelli is currently the Behavioral Health Clinical Program Manager for Hackensack Meridian Health.



Raymond F. Hanbury, Ph.D., FAPA

Raymond F. Hanbury is Chief Psychologist, Director of Psychology Education, and Program Director of the Pediatric Psychiatry Collaborative Program at Jersey Shore University Medical Center, Department of Psychiatry. He is board certified in clinical psychology, addiction

psychology and trauma psychology and holds diplomate and fellow status in the clinical areas of his practice. Dr. Hanbury is Clinical Associate Professor at Rutgers – Robert Wood Johnson Medical School and also at Rowan University School of Osteopathic Medicine, both in the Department of Psychiatry. Dr. Hanbury is the co-founder of the Society of Addiction Psychology in the American Psychological Association.



Anthony Castellano - Preferred Behavioral Health Group

Anthony Castellano holds a master's degree in social work from Fordham University and is a Licensed Clinical Social Worker, New Jersey State Licensed Clinical Alcohol and Drug Counselor, a New Jersey State Certified Clinical Supervisor, and Internationally

Certified Alcohol and Drug Counselor and a Certified Field Instructor. Anthony is affiliated with the Ocean, Monmouth, Hudson, Passaic and Mercer Consortiums and is an Ocean County Drug Court Consultant. He currently is partnering with Ocean County Prosecutor Joseph D. Coronato to find ways to decrease the opioid overdose rate in Ocean County. Anthony is working with the Heroin Addiction Response Treatment (HART) program, and his division was awarded the Support Team for Addiction Recovery (STAR) program grant in Monmouth County.
