Eugene Decker, DO

Eugene Decker is the Medical Director for the St. Luke's Warren Hospital Family Medicine Residency Program. For the past 25 years, he has practiced medicine at Coventry Family Medicine in Phillipsburg. He also serves as the Medical Director

for the DeSales University Physician Assistant Program. Dr. Decker lectures to the residency and physician assistant programs about the New Jersey and Pennsylvania prescription monitoring programs.
